To our Producers,

Our longstanding partnership of over twenty years with QBE will be coming to an end October 1, 2018. For most of our current QBE policyholders we will be offering replacement policies through the Greenwich Insurance Company or the Indian Harbor Insurance Company as our policies with QBE Insurance Corporation and QBE Specialty Insurance Company expire over the next year.

While we are legally obligated to advise the insured and other policy interests that their policy through the QBE Insurance market will not be renewed, in most instances we will be doing so through a consumer friendly letter captioned "INSURANCE COMPANY CHANGE NOTICE". This letter informs the insured and other policy interests that their policy through QBE will not be renewed at expiration but that replacement coverage will be offered to them through an alternative market with the same terms and conditions as their expiring policy. A sample copy of this letter is enclosed for your review.

We will be making every effort to provide you and your clients with expiring QBE policies with replacement quotes at least 60 days in advance of policy expiration. In the event that we are unable to provide a an acceptable replacement for the expiring policy either due to a lack of an alternative market or underwriting reasons that would preclude renewal, a more standard notice of non-renewal will be issued.
